More specifically it caters to the requirements of the women in distress as regards primary need, shelter, medical, emotional support, counseling, rehabilitation, clinical, and legal support.



#### **Our Mission:**

Safe Shelter is committed to empowering victims of physical, emotional, and sexual violence by offering information which will allow them to choose their own courses of action and by supporting them as they act on those choices. We are further committed to educating the public on the issues surrounding domestic and sexual violence so that together we may challenge societal attitudes which condone the use of violence as a means of gaining and maintaining power and control over another person.

#### Our Philosophy:

SEHADA is running the Swabhiman Home with the support of District Mineral Foundation Trust, Jharsuguda.

- > To provide safe shelter to destitute women and their children of Jharsuguda district with dignity
- To provide vocational training for self sustainable and counselling them to reintegration



- To provide counselling, police assistance and legal support for destitute women

During the year 163 women and 67 children admitted in swabhiman home and 164 women and 67 children successfully rehabilitated. At present 15 women and 12 children residing at Swabhiman Home.



#### RAJAKANYA (FIT FACILITY CENTRE) UNDER SWABHIMAN HOME

SEHADA is running the Fit Facility Centre under Swabhiman Home with the support of District Mineral Foundation Trust, Jharsuguda. The project will be tie up with Swabhiman Home as per declared by Child Welfare Committee, Jharsuguda.

- a) To cater to the primary need of shelter, food, clothing, counseling, medical treatment and care and protection of the sexually abused girls in age group of 12-18 years.
- b) To enable them to regain their emotional strength that gets hampered due to their encounter with unfortunate circumstances.
- c) To provide them with legal aid and guidance to enable them to take steps for their readjustment in family/society.
- d) To rehabilitate them economically and emotionally.
- e) To act as a support system that understands and meets various requirements of girls in distress and difficult circumstances.

#### STATE SUPPORT CENTRE

With the support of Ministry of Women and Child Development, Govt. of India, SEHADA has taken responsibilities to run State Support Centre at Jharsuguda district at District Head Quarter Hospital(4<sup>th</sup> floor)from 7<sup>th</sup> November 2019.



#### **About One Stop Center (Sakhi)**

One Stop Centre (OSC) is intended to support women affected by violence, in private and public spaces, within the family, community and at the workplace. Women facing physical, sexual, emotional, psychological and economic abuse, irrespective of age, class, caste, education status, marital status, race and culture will be facilitated with support and redressal. Aggrieved women facing any kind of violence due to attempted sexual harassment, sexual assault, domestic violence, trafficking, honour related crimes, acid attacks or witch-hunting who have reached out or been referred to the OSC will be provided with specialized services.



#### **OBJECTIVES**

The objectives of the Scheme are:

- ➤ To provide integrated support and assistance to women affected by violence, both in private and public spaces under one roof.
- ➤ To facilitate immediate, emergency and nonemergency access to a range of services including medical, legal, psychological and counselling support under one roof to fight against any forms of violence against women.



#### **TARGET GROUP**

The OSC will support all women including girls below 18 years of age affected by violence, irrespective of caste, class, religion, region, sexual orientation or marital status. For girls below 18 years of age, institutions and authorities established under Juvenile Justice (Care and Protection of Children) Act, 2000 and the Protection of Children from Sexual Offences Act, 2012 will be linked with the OSC.
